Procedure:

1. As the Sheriff's Office continues to evaluate booking criteria, the following offenses will be bookable:
 - 1.1. Any Class A, B or C Felonies
 - 1.2. Any "Person Class A Misdemeanor" as set forth in OAR 213-003-0001(15)
 - 1.3. ORS 164.335 Reckless Burning
 - 1.4. ORS 164.354 Criminal Mischief II
 - 1.5. ORS 166.250 Unlawful Possession of Firearms
 - 1.6. ORS 166.240 Carrying of Concealed Weapons
 - 1.7. ORS 166.190 Pointing Firearm at Another
 - 1.8. ORS 166.180 Negligently Wounding Another
 - 1.9. ORS 166.425 Unlawfully Purchasing a Firearm
 - 1.10. ORS 813.010 Driving Under the Influence of Intoxicants
 - 1.11. ORS 811.140 Reckless Driving
 - 1.12. Any offense subject to mandatory arrest under Oregon law

MCSO members and members of our partnering agencies shall not book any individual charged with an offense that is not specified in this Special Order.
